Yaakov Ariel

Dr. Yaakov Ariel is a graduate of the Hebrew University of Jerusalem and the University of Chicago, where he completed a doctoral degree on Christian Messianic groups and their relation to Jews and Zionism. His research focuses on Protestant Christianity and its attitudes towards the Jewish people; on Jewish-Christian relations in the modern era; and on the Jewish reaction to modernity and post-modernity. His second book, Evangelizing the Chosen People, was awarded the Albert C. Outler prize by the American Society of Church History. Dr. Ariel is a professor of religious studies at the University of North Carolina at Chapel Hill.

Mitch Glaser

Dr. Mitch Glaser has served as president of Chosen People Ministries since 1997. He is an alumnus of Northeastern Bible College, the Talbot School of Theology and earned a Ph.D. in

Intercultural Studies from Fuller Theological Seminary, School of Intercultural Studies. His dissertation explored the history of the Messianic Jewish movement in Continental Europe during first half of the twentieth century. Dr. Glaser is recognized as an expert on the role of Messianic ministries during the Holocaust period. He is the co-author of The Fall Feasts of Israel with his wife, and co-editor of To the Jew First, The Gospel According to Isaiah 53, and The People, The Land, and The Future of Israel, published by Kregel Publications. Dr. Glaser's book Isaiah 53 Explained, is now in fourteen languages with over 200,000 copies in print. He has written many articles for a variety of periodicals and has taught at leading schools such as Talbot School of Theology, Fuller Theological Seminary, and Moody Bible Institute. Dr. Glaser lives in Brooklyn which he whimsically describes as the true Holy Land.

Motti İnbari

Dr. Moti Inbari is an associate professor of religion at the University of North Carolina at Pembroke. Dr. Inbari's research focuses primarily on Jewish fundamentalism, mostly in Israel, but also in the United States and Europe. He is the author of three books: Jewish Fundamentalism and the Temple Mount (2009), Messianic Religious Zionism Confronts Israeli Territorial Compromises (2012), and Jewish Radical Ultra-Orthodoxy Confronts Modernity, Zionism, and Women's Equality (2016). Dr. Inbari earned his PhD at the Institute of Contemporary Jewry currently part of the Department of Modern Jewish History—at the Hebrew University of Jerusalem. He has also served as a fellow at the University of Florida and at the Schusterman Center for Israel Studies at Brandeis University.



Mendi keren

Dr. Mendi Keren is a researcher of Hungarian Orthodoxy and of contemporary ultra-Orthodox society in the State of Israel. His field of interest lies in the history of Jewish Orthodoxy; Yiddish literature and press; Haredi society in Israel and the United States; the Old Yishuv of Jerusalem; Jewish folklore; and Jewish and rabbinic genealogy.

alan Shore

Dr. Alan Shore has pursued a multi-faceted vocation for over 40 years that includes service in ministry and education. From 1991-95, he was adjunct instructor in Biblical studies at Trinity Western University in Langley, British Columbia. He holds an M.Div. from Fuller Theological Seminary in Pasadena, CA (1991) and a Ph.D. in Modern Jewish History and Culture from the Graduate Theological Union in Berkeley, CA (2016), with an emphasis on Yiddish language and literature and Jewish-Christian relations in America. Since 1998, he has served on the staff of Chosen People Ministries in a number of roles including staff writer and National Ministries Representative. He is presently Special Assistant to Dr. Glaser.

Introduction

Alan M. Shore

As many of both sides of the border have discovered, interfaith dialogue between Jews and Christians is a frustrating and often fruitless exercise. How more so is *intra*-faith dialogue between Jew and Jew, especially since one of the saddest codas to any Jewish discussion is often, "I'm sorry to say I agree with you." For then, what more is there to argue about?

Normal conversation between Messianic Jewish believers and other Jews is particularly difficult because emotions tend to run high. For some time, Jewish believers have asked, is there a more neutral space where Jews of various viewpoints can work toward constructively adding to one another's knowledge and perspective?

It turns out that there is, in the environment of a shared love of scholarship. In the past ten years, Messianic and non-Messianic scholars have met together on numerous occasions on topics of shared interest, in an atmosphere of friendliness and mutual respect. Studies (JMJS), sponsored by the Charles L. Feinberg Center for Messianic Jewish Studies, consists of articles collected from such a conference held at the Feinberg Center entitled, "The Life and Times of Leopold Cohn," which took place on December 4-6, 2019.

2019 was a milestone year for Chosen People Ministries, for it marked the 125th anniversary of the founding of the mission by Leopold Cohn in the Brownsville section of Brooklyn in 1894. Chosen People Ministries marked the occasion with conferences throughout the year in North Carolina, California, Wisconsin, Maryland and a gala banquet in Brooklyn. The idea to organize a conference to explore various facets of the history of the Mission came almost as an afterthought. Ironically, it was put forth by an outside source, Dr. Mendi Keren. Dr. Keren, whose work you will encounter later in the pages of this journal, is one of a number of non-Messianic Jewish scholars with whom Dr. Glaser and others on staff have cultivated cordial and collegial relationships.

This conference takes place in the context of a relatively newly aroused academic interest in the history of Jewish evangelism and missions to the Jews. It is quite natural that Chosen People Ministries, formerly the American Board of Missions to the Jews (ABMJ), should play a prominent role in this field, being one of the oldest and most influential organizations that is on the scene today. As well, the remarkable fact that the work was presided over for almost sixty years by the father-son combination of Leopold and Joseph Hoffman Cohn adds additional interest from the standpoint of contrasting personality and leadership style in the organization's development. As I hope you will find, each of the contributors found different and fascinating aspects of the Mission's history and, in some cases, offered differing perspectives as well.

My thanks to Dr. Glaser, who served as Executive Editor,
